### The State of the Guild

#### Fellow NWG Members:

The State of the Guild is one of transition. Beyond the recent transition in leadership, the growth we have seen over the past few years under Wayne's leadership has brought us to a point where we need to plan more strategically and rely on members more for the activities of the Guild.

At this time, your board is finalizing plans for a strategic planning session where we will be discussing, among other things, the mission, vision and values of the organization and its short-term and long-term goals. We will be discussing ways to strengthen the committee structure to help train up the next generation of Guild leadership. Building capacity in our members will allow them to be able to assume leadership positions and will give us a much stronger organization than by asking people to take on the responsibilities of a board or officer position without the benefit of past experience. We also need develop ways to turn over events to interested volunteers to relieve the burden on board members who serve.

As of the last board meeting, Guild membership was 293 with 26 active non-board volunteers. The Guild accounts were up slightly with combined balances of approximately \$12,000. The Guild continues to expand events and engage members. The report of events at the last board meeting included:

- 2018 Greater Nebraska Writers Conference, October 12-13, Aurora
- 2018 Poetry Retreat, Nov 3, Nebraska City, 5 paid registrations with additional openings

# Change in Officers and Board Members of The NWG

As shared via email a few days ago, Wayne Anson has resigned as President of the Nebraska Writer's Guild for personal reasons, but will continue to serve on the board in the role of Immediate Past President.

Section 6.4.2 of our bylaws reads "If the office of President becomes vacant, the Vice President shall assume the office of President or may act as interim President until the Board appoints another qualified General Member to complete the unexpired term. If the Vice President assumes the Presidency, the position of Vice President shall be filled by appointment in the manner described above...."

I worked with the board to determine which scenario would be most likely to benefit the guild moving forward, considering both short-term and long-term implications of the choice. As announced, I assumed the presidency and the board approved the appointment of Past-President Victorine Lieske to fill the remainder of my term as Vice President and for her to appear on the ballot at fall conference for that office.

In the announcement previously released, I promised further details about how we came to this decision. I plan for board business to be transparent and straightforward. I feel that this transparency is especially important due to the fact that the resolution to our situation was to put a husband and wife team at the top of the ticket.

Let me share with you some of the specifics items shared through individual and group discussions as we worked to reach consensus on this issue:

- 1) The board feels that this patch provides the best transition possible to an era of new leadership. My past experience with other boards will help us set a framework for future growth. Victorine's experience as a past Guild treasurer and president, and as an attendee and presenter on the national circuit make her the perfect candidate for the office with the main responsibility of planning conferences. Additionally, her experience and institutional knowledge will be valuable as she continues to serve on the board in this new capacity (having served most recently as Immediate Past President). Together we make a good team, along with our other current board members, to train up the next generation of Guild leadership.
- 2) There are checks and balances in place to protect the Guild. Financially, the Treasurer is responsible for the accounting of the Guild. The Vice President has not typically been an authorized signer on the bank account. It would be my expectation that the Guild Treasurer would receive statements and written communication from the bank and have uninhibited access to accounts online at any time without notice. A second board member could also be set up in the capacity as a second check to mitigate any concerns.
- 3) While the Guild bylaws do not allow for write-in candidates for Guild elections, should a problem arise, there are mechanisms within our bylaws that allow for the board or general members to remove an officer for cause. Our election cycle will also serve as a check, as I will be up for election in 2019 and Victorine would be up for election in 2020. We are in talks with a member who hopes to gain experience through committee work over the next two years in hopes of giving her a foundation for a possible VP run in 2020, if she is so inclined at that time.
- 4) There were concerns raised about the possible dynamic on the board with a husband and wife team at the top. Would board memebrs feel free to raise objections if we were to bring forward a plan that they disagreed with? I have worked to assure the board that professionally, I surround myself with strong folks and I find robust conversation and differing views valuable in reaching the most creative solutions possible. It is my hope that as the board gets to know Victorine and me better as a leadership team, this concern will lessen.

5) Another concern raised, though not directly related to us being a married team, is that we need to try and keep a balance of eastern and western representation on the board as we add new members. Victorine and I both being from the West creates a further lean that direction. Kim Stokely, who is on the October ballot for Recording Secretary is from Bellevue, and the individual we are in discussions with to serve as a Conference Committee Chair with hopes for a 2020 VP run is from the Omaha area as well.

The way I will need to function as President will look different than how Wayne was able to operate. I still work full-time and have other responsibilities outside the Guild. Victorine will be able to complement my limitations well as we work to groom committee leaders, memebrs and new board members to lift the load during this transition and beyond. Additionally, asking someone to come forward and take on the main responsibility for conferences without the benefit of experience on that arena would not be fair and could jeopardize our main revenue stream.

With that being said, I was straightforward with the board, and want to be straightforward with the membership, in disclosing that Victorine and I had been working with Wayne on an expanded Spring conference that includes a writer's retreat, live broadcast and classes from The Writing Gals. This is a group co-founded by Victorine that has had an impact on attendance at other conferences. Victorine's cohosts have agreed to help the Guild build a financially successful Spring Conference by appearing without honorarium and minimal expense reimbursement. One of her cohosts even changed the location of their family vacation to Omaha to accommodate the event. I felt it important to disclose this as to avoid the appearance that Victorine's ascension into the Vice Presidency had any influence on these plans.

While I worked with the board to gain consensus on these issues, the vote was not unanimous. Of the seven voting members of the board at the time, four approved Victorine's appointment and addition of her name to the ballot, one voted no, one abstained and one did not vote. The member voting no was comfortable moving forward, noting a better solution could not be seen for the short-term needs of the Guild.

I would also like to say that if at any time any member has concerns related to board business, s/he should feel free to contact any board officer or member to bring these things to light. Also, as President, one of my duties is to set the agenda for board meetings. I will be looking into ways we can have general members join public portions of board meetings via technology or in person, and we can even establish a protocol for members to have floor time during the meeting.

On another note, I would also like to shine a spotlight on Carrie Gray. At the August board meeting we added Carrie as a new general board member. She is from Grand Island and will serve as the Social Media Chairperson. We are excited to have Carrie serve the Guild through her knowledge of social media and look forward to the fresh perspective she will add to board discussions.

The office of Membership Secretary (proposed to be changed to Membership Coordinator) remains vacant and eligible for appointment.

# The Broadside is Now Twenty-Eight

The first Nebraska Writers Guild Broadside was dated July, 1990. That makes this the third issue of the twenty-eighth year. In the early editions, it was a "place look for answers to your writing questions, for information about other guild members, for advice on any variety of topics or for whatever else you see fit."

The goal at that time was to make it a quarterly newsletter. At the time the Broadside was first produced, the Bulletin was the only guild publication, and it was sent out just before the two conferences. Those Bulletins had the program of the upcoming conference and a membership list, along with a summary of what the members had written or published.

The Broadside's first issue included member news, a "state of the guild" article, an article on copyrights, requests for volunteers, and upcoming events. The Broadside's first editor was a new member at the time, Jana Pedersen. Since its inception, the Broadside has had three masthead designs, the current one being first used in 2003.

A copy of the first issue is in the Nebraska Writers Guild archives at the Nebraska State Historical Society building at 15<sup>th</sup> & R Streets, in Lincoln. The archives is open to the public for viewing. One has to know what they are looking for and it is retrieved for use in the resource room on first floor. The cost is very easy on the pocket book, only a quarter per copy. Photos are free, if you bring your own camera.

Here is a "Did You Know?" that was in the first Broadside, I believe Robert Guenzel is the person who belongs to the initials. "To get to Denver from western Nebraska, you must drive downhill. In Kimball County, Nebraska reaches an altitude of over 5,400 feet. Denver sits at only 5,200 feet. So, driving from the Nebraska border to Denver requires a drop of about 200 feet! Personally, I love pointing that out to people from Denver. R. C. G.

### Nebraska Writers Guild, A Sponsor of Nebraska Book Festival 2018

The Nebraska Writers Guild was one of nine featured sponsors of the Nebraska Book Festival. Beside having the NWG tables among the vendors, it had half of the eighteen presentation/lectures in a room designated as the Nebraska Writers Guild Room. The union auditorium was the other room for the presentations and speakers. The five presentations, by guild members included Margaret Lukas (editing manuscripts) Johnnye Gerhardt (dialogue writing) a writing prompts hands-on class by Katherine Wielechowski and Sarah Buhrman in the morning. Nancy Sharp Wagner with a lively presentation in the afternoon on public author events and Lisa Pelto, presented a class on self-publishing in the afternoon. All of the presentations were well attended.

Readers for guild were, Charlene Pierce, Kolleen Meyr-Krikac, Margaret Lukas, Johnny Gerhardt, Steve Bruttig, Laura Madeline Wiseman, and others not listed in the program. Stew Magnuson, Omaha-based author and researcher, spoke on the challenges of narrative nonfiction, and gave ideas to help the writer in that genre.

Cort Fernald was the guild representative moderating the Nebraska Writers Guild room activities, while Faith Colburn took the helm of the Guild's booth.

### Life Member Spotlight

Starting with this issue, the Broadside is going to devote a page to a Guild Life Member. This issue we will be spotlighting the late Hannie Wolf. She passed away on May 21<sup>st</sup> of this year.

### Hannie Wolf

Hanne Lore "Hannie" Wolf was born in 1925 in Ulm, a city in the south of Germany on the Danube in 1925. She was the only child of Felix Baer, a successful grain dealer and Hilde Frankfurter.

After Hitler rose to power in 1933, Jews were forbidden to associate with Christians. Hannie and her Catholic friend Rosemary, talked using the bathroom pipes in their building. During the lead up to the war, Hannie's father was arrested and sent to Dachau concentration camp. Her mother showed proof that Felix was a veteran of the first World War and got him out.

They then bribed officials to get affidavits to come to America. They traveled through Russia and China to reach America. During the sea voyage, they were hit by a typhoon. Hannie always said she thought they would never make it. When they landed in Seattle, it was Halloween, amazing them with all the dressed up characters. Soon after that, they went to Portland, eventually reaching Denver, and Golden, Colorado.

She met her husband, Bob Wolf at a dance and they were married two weeks later. They moved to Albion in 1950 and had one son, Bill.

Hannie wrote a book, *Child of Two Worlds, an autobiography. As a Holocaust survivor*, she gave presentations to schools. One was in 2012 at the Archbishop Bergan Catholic High School in Fremont. It was covered by the Fremont Tribune newspaper.

The following story was written, in April, 1998, by NWG Life Member, Hannie Wolf. It was found in the Nebraska Writers Guild archives at the Nebraska State Historical Society Archives.

There. Is a difference. Mrs. B.never met a carpet she didn't like. I can't tell one carpet from another. Her brain has a built-in calculator. I can barely add two and two.

What we do have in common, is an appreciation for life, liberty and the pursuit of happiness. She finds happiness riding around her vast empire in a motorized cart. I find happiness sitting in a cramped basement room, pounding the keys on my old typewriter.

It proves that happiness can be found anywhere if we are willing to search for it.

In 1926, the guild membership roster listed 126 active, honorary and associate members.
